CONTRACT

Between _____, hereinafter, referred to as "Titlist"
and the Tri County Fair;

1.) Titlist agrees to and/or certifies the following:

_____ I attest that I am a legal citizen of the United States of America and a legal resident of either Grant, Hardy, or Pendleton Counties of West Virginia.

_____ I attest that I have reached my 16th birthday by January 1, 2019 and will not have turned 22 on or before January 1st, 2019

_____ I have never been married or had a marriage annulled;

_____ I have never borne a child;

_____ I agree to remain single during my reign and not to become pregnant and understand that if either of these occurs this contract will become null and void;

_____ I attest that I am of good moral character and have not been convicted of any major crime;

_____ I attest that I have not heretofore made any legal obligations that would prevent or limit my participation as Titlist and that I am not the current titleholder nor have ever held the title of Miss Tri-County Fair Queen.

2.) I agree that I am satisfied with the manner in which the pageant and its' judging was conducted. _____

3.) I agree to cooperate and communicate with the duly appointed Director(s) of the Tri-County Fair Queen's Scholarship pageant and any representative of the Tri-County Fair. _____

4.) I agree to reign over the Tri-County Fair and participate in all activities required by said event: including but not limited to:

_____ riding on the Queen's float in the Tri-County Fair parade on Wednesday, July 31, 2019

_____ 8/3/19

_____ representing the Tri-County Fair at the West Virginia Association of Fairs and Festivals Queen of Queens pageant on January 9-11, 2020 in Charleston (entrance fee and hotel room will be provided, as well as \$100.00 for expenses);

_____ riding in the West Virginia Poultry Association Convention and

Festival's parade on Thursday July 23, 2020;

_____ being present for pageant practice on Friday, July 26, 2019 at 6:00pm

_____ reigning over any necessary events of the Tri-County Fair,
July 30, 2019 thru August 3, 2019

_____ being present and participating in the 2020 Tri-County Fair
Queen's Scholarship pageant, including crowning the 2020 Tri-County
Fair Queen on Monday, July 27, 2020.

- 5.) I understand that, at my own expense, I may arrange to attend official function of any recognized Fair and/or Festival which is a member of the West Virginia Association of Fairs and Festivals. I further understand that it is my responsibility for travel expenses to and from these events. The Tri-County Fair is not responsible for any such expense.
- 6.) I agree not to incur any debts on behalf of the Tri-County Fair.
- 7.) I agree not to enter or participate, as a contestant, in any other West Virginia Association of Fairs and Festival pageant or contest during the term of this agreement, until after representing the Tri-County Fair at the West Virginia Association of Fairs and Festivals Queen of Queens pageant in January 2020. I further agree to relinquish any titles I now hold other than this one.
- 8.) I agree not to be photographed as the reigning Titlist, with or without the banner and crown, for any publications, including calendars, without written consent of the Tri-County Fair. Furthermore, any photographs of Titlist, which makes reference to the title, must be seen and approved by the Tri-County Fair before being distributed to the public (distribution includes photographs that are or will be posted on Facebook or MySpace).
- 9.) I agree to allow the duly appointed Director(s) of the Tri-County Fair Queen's scholarship pageant access to my Facebook, Instagram, & Twitter pages by adding them as a friend.
- 10.) I certify that I have not participated in any activities which would be embarrassing to me and/or the Tri-County Fair prior to this agreement. I also agree that if during my year of reign, I do engage in any such activity, including being arrested and charged with a crime, the Tri-County Fair shall have the right to declare this contract null and void and I must return all awards and/or prizes to the Tri-County Fair.

11.) I agree to the following regarding to the payment of awards and/or prizes:

_____ Receipt of sash, crown, flowers and a gift bag on the night of the pageant;

_____ will receive entrance fee to West Virginia Association of Fairs and Festivals Queen of Queen's pageant and hotel room provided for the aforementioned event, as well as \$100 for any expenses,

_____ will receive a \$1,000.00 scholarship to be paid to the higher educational institution of the Titlist's choice, providing the contract had been fulfilled. The necessary information for receipt of the scholarship must be provided by the Titlist to the Director(s) on the night the Titlist relinquishes her title. Titlist will be given the appropriate notice prior to.

12.) Use of this contract acts as an agreement that your photos may be used in any publicity for this event.

IT IS UNDERSTOOD THAT THE TERM OF THIS AGREEMENT IS JULY 29, 2019- AUGUST 3, 2019.

With my signature, I certify that I have read this agreement and understand it. I further understand that in the event that I do not fulfill **ANY** of the above requirements, unless extenuating circumstances prevail, the Tri-County Fair shall have the right to terminate this agreement and select a successor at its' discretion.
