Entry Blank RULES AND REGULATIONS

- A. Each driver must fill out an entry blank. Entries limited to area and adjoining counties only.
- B. All rules and regulations must be observed. Track operators or promoters reserve the right to approve or reject any and all entries.
- C. Only owners, drivers, or mechanics will be permitted in the pit area or on the track. ENTRY FEE-\$25.00 (NO REFUNDS) This covers driver only. The entry fee must be cash or money order. No personal checks. All pit passes are \$20.00
- D. NO CARS permitted on the track before the heat they are to participate in.
- E. MEMBERS OF THE AUTO DEMOLITON DERBY, are not employees of the track operator or the promoter of the Auto Demo Derby.
- F. NO ALCOHOLIC BEVERAGES allowed in the pit area, drivers that are drinking will be disqualified. Breathalyzer test may be given.
- G. TIRES MUST BE STOCK SIZE, 4-ply only, no inner liner, no truck tires, no snow or mud treads, no doughnuts.
- H. NO ANTIFREEZE OR FREON ALLOWED.
- I. NO WELDING Drivers door may have a piece of flat steel 1/4" x 4"-no longer than the drivers door plus 4". You may use a chain behind the drivers door.
- J. ELECTRIC FUEL PUMPS ALLOWED in original gas tank as long as seal is not broken. Any fuel lines in drivers compartment must be inside conduit. All electric fuel pumps must have a power shut-off switch. NO EXCEPTIONS!!!

DRIVERS ENTRY

- 1. DRIVERS MUST HAVE A VALID DRIVERS LICENSE. Under 18 must have a minor consent form.
- 2. ALL DRIVERS MUST SUPPLY THEIR OWN CARS. Entries limited to 2 cars per driver, per night.
- 3. ALL DRIVERS AND CARS must be entered and at the track 2 hours before the scheduled starting time of the derby.
- 4. ENTER EARLY! THERE WILL BE A FIFTY CAR LIMIT PER DERBY.
- 5. ANY DRIVER DISOBEYING THE RULES WILL BE DISQUALIFIED.
- 6. Paint this number

on each side of your car in large, bright colors.

PARTICIPATING REGULATIONS

- 1. Any <u>COMPACT</u> 4-CYLINDER foreign or domestic automobile. No diesels, electrics, headers or 4-wheel drives, maximum weight 2750 per N.A.D.A. book.
- 2. <u>ALL GLASS AND CHROME TRIM</u> and anything that might become imbedded in the track, must be removed from the car before bringing auto to the grounds. Also, car must be cleaned out including the trunk. Don't leave broken glass in doors, clean them out. WINDSHIELD IS OPTIONAL. Fiberglass nosepieces, wheel weights, headlight buckets, trunk and hood latches must be removed.
- 3. A MAXIMUM OF THREE (3) GALLONS OF GASOLINE will be allowed.. GAS TANKS-METAL ONLY must be moved to the trunk or will be allowed in drivers compartment if coverd by a firewall. ONLY ONE (1) STOCK CAR BATTERY will be allowed. Must be covered.
- 4. NO REINFORCEMENTS OF ANY KIND WILL BE ALLOWED. Trailer hitches must be removed.
- 5. SAFETY BELTS AND HELMETS are required.
- 6. DRIVERS MAY MANEUVER FORWARD OR BACKWARD. No deliberate head-on collisions or deliberately ramming drivers door. This can lead to disqualification.
- 7. A TIME LIMIT will be set by the judges. IF A DRIVER DOES NOT HIT A LIVE CAR WITHIN THE LIMIT, this can lead to disqualification. DO NOT PLAY POSSUM!
- 8. Do not weld or bolt hoods or trunk lids down. Use wire,
- 9. THE DERBY WILL BE COMPOSED OF INDIVIDUAL HEATS AND FEATURE with cash prizes going to each heat winner and grand prize to feature winner. Feature will be comprised of winners and runner-ups of each heat when show is single derby event. Feature will be comprised of winners of each heat from each show when there are two or more derby events.
- 10. ADDITIONAL SAFETY REGULATIONS MAY BE IMPOSED depending on track.
- 11. A 12 by 15 inch hole must be cut in the center of the hood.
- 12. Rules are subject to change to fit the event. THE DECISION OF THE JUDGE IS FINAL.
- 13. All cars must be removed by midnight day of derby.
